### **Requesting permission to take a photos and videos in high - angle by using a Drone. (For Private use) In Noppharat Thara - Mu Ko Phi Phi National Park**

1. Book to Head of Hat Noppharat Thara - Mu Ko Phi Phi National Park with specifying the following details.
  - 1.1 Objective of taking photos and videos by use drone.
  - 1.2 Area where taking photos and videos (Identify every point that will go to fly drone)
  - 1.3 Date of taking photos and videos.
  - 1.4 Travel agency that you travel with.
2. Requesting permission to take a photo and videos by using a drone for personal.
3. Copy of citizen ID card or passport and signed your name to certify information.
4. Copy of license of who controls or launches an aircraft which has no pilot and signed your name to certify information.
5. Copy of registration certificate Radio communication equipment for aircraft which has no pilot (according to the criteria required by law) and signed your name to certify information.

Remarks Submit documents at least 5 days in advance to provide a suitable consideration period.

4. Permission applicant will not do anything that will have an impact on wildlife and do anything that violates the law on national park or direction of Park ranger.
5. In case of damage to government property due to the action of the applicant for permission must be responsible for compensating the government for damages.
6. Permission applicant will comply with rules laws regulation and conditions according to Section 20 , Section 22 and Section 29 of the National Park Act, B.E. 2019 and the regulations of the National Park, wildlife and Plant conservation Department regarding entry into National Park B.E. 2020 Section 5(7) including the announcement of the ministry of Transport regarding the criteria for requesting permission and conditions for controlling or releasing aircraft without a pilot in the category of externally controlled aircraft, B.E. 2015 both currently in use and/ or issued number to enforce in strictly the future.
